- Councilwoman Brenda Hawkins spoke briefly thanking everyone for attending, holiday or recognition days from October 16th to November 13<sup>th</sup> like happy birthday, anniversary, retirement or whatever, Halloween, Election Day November 7<sup>th</sup>, Veterans Day is November 11th, daylight savings time will be November 5<sup>th</sup>, flu shot were given a week ago with 20+ people taking advantage of the opportunity, thank you Susan and council for addressing the dog issue, how will resident know of the new ordinance. Questioned about falling limbs and dead trees on a property, is there something that can be sent out to property owner to do clean up. Attorney Keen stated that the nuisance ordinance would cover it. HGTV chose Ocracoke, NC came up as a charming town in America.
- Councilwoman Mary Moye spoke briefly thanking everyone for coming out, early voting starts October 19<sup>th</sup>, today there was a ground breaking for at Pitt County Ag Center for a new community recreation center, on October 23<sup>rd</sup> at 4pm there will be a ground breaking at Alice Keene District Park for a new gym. Stated that Janis Gallagher, Greenville City Manager, that the Simpson Fire Department received from American Resource Planning funding workshop \$200,000.

### **MAYOR REPORTS:**

Mayor Richard Zeck spoke briefly

- Financials are in good shape; emergency funds are in place.
- Green Light Proclamation supporting Operation Green Light for Veterans, last census shows around 10% of residents were veterans or are spouses of veterans, like to propose we adopt the proclamation.
- Ask Attorney Keen to update the changes of the proposed dog ordinance.

# **ITEMS FOR DISCUSSION:**

- Proclamation for Supporting Operation Green Light
- Review updated dog ordinance changes Keen shared the current dog ordinance for comparing the updated one. Stated a number of sections that are out of date, on the draft licensing has been removed, tags and collar needed to be modified, add need of rabies inoculation, and a rabies tag. Definition of kennel, added commercial breeder, and the

number of dogs allowed on properties. Council agreed to allow three (3) female dogs, over six (6) months old, at their commercial kennel.

A motion was made by Mayor ProTem Dianne Thomas to approve the adoption of the Green Light Proclamation. Councilwoman Brenda Hawkins seconded the motion. All voted "Aye", the motion was carried.

A motion was made by Councilwoman Brenda Hawkins to approve the updated dog ordinance, effective January 1, 2024. Councilwoman Mary Moye seconded the motion. All voted "Aye", the motion was carried.
